2021-22 Opportunities for Parental Involvement

The success of children depends heavily on the school community, parents, and extended community working together. The benefits of these partnerships are immeasurable. Communication between home and school is regular, two-way, and meaningful. Parents receive weekly updates and/or progress reports from the classroom teacher, monthly school calendars, weekly calls home, and newsletters. Official and classroom notices are sent home in English and Spanish. Parent conferences are held twice per year with follow-up meetings as needed. The School Messenger notification system is used regularly to distribute information via phone, email, and text to all families and staff members.

Parents play an integral role in assisting student learning. Parents are provided information regarding how parents can foster learning at home, give homework assistance, and provide feedback to teachers. School sponsored workshops are held on a regular basis to assist parents in understanding how students can improve skills, get help when needed, meet class expectations, and perform well on assessments. Math night, Dr. Seuss Night, family game night, and many other events are held each year to provide opportunities for families to come learn and have fun together at Jackson Heights. Due to COVID, most of these events have been held virtually.

Parents are welcome in the school and their support and assistance are sought. Parents are full partners in decisions that affect children and families. Open dialogue, both formally and informally, is encouraged through an active School Site Council, English Learner Advisory Committee, District English Learner Advisory Committee, and Parent Teacher Club. Lastly, community resources are used to strengthen schools, families, and student learning. Jackson Heights Elementary School works in partnerships with local business and service groups (Baskin Robbins; Rotary; Wal-Mart.) to provide student incentives and rewards for academic and behavioral excellence. While COVID-19 restrictions have limited volunteer opportunities on the campus, our stakeholder groups still meet on a monthly basis.

Each school receives an instructional budget based on enrollment, programs, and formulas set by Board of Education policy, state law, agreements with bargaining units, and guidelines of outside funding sources. The School Site Council (SSC) meets approximately once a month to develop, implement, monitor, and evaluate the school plan for student achievement. School plans align with the district's Local Control Accountability Plan (LCAP). Parent representatives are elected to the School Site Council and serve two year terms. All parents are welcome and encouraged to attend these meetings, as well as the District Advisory Committee (DAC) meetings, as a way to learn more about our school funding and academic goals.
